Please refer to an elaborate circular issued by the Member secretary dated 22/4/2014 under the above reference on the captioned subject. It has been decided that the matters being filed before Hon'ble NGT, Western Zone, Pune Bench & Principal Bench New Delhi will be classified into two categories for the purpose of initiating timely actions in compliance of the subject matter and various orders passed by Hon'ble NGT Bench from time to time, namely, 1) The matters having local jurisdiction, not involving policy decisions will be handled exclusively at the local level & 2) The matters involving important issues & Policy decisions, which are required to be approved by the HQ shall be routed through the concerned HOD and Policy & Law Division. In appropriate cases subject specific HOD should be involved.

In order to adopt more systematic approach and to develop the expertise in the field of various subject/sources of environmental pollution, the P&L Div. has been asked to finalize a list of Subject- Specific Advocates for Air issues, Water issues(industry), Water issues(River & STP), CETP issues and MSW-BMW-HW issues before NGT. After going through the available list of Panel Advocates, the Policy & Law Division has tentatively finalized the following Subject-Specific-Advocates for various issues, which will be further reviewed on the basis of the conducting of various matters after 6 months, as under :

It has been decided that the Policy and Law Division to finalise notable Panel Advocates/legal Firms and to post LO/ALO to be contacted for preparation of draft affidavits by the concerned ROs to prepare draft affidavits in consultation with them, which are not involving policy decisions and important issues and get it affirmed on the basis of factual record and legal position exist at their jurisdiction (Chandrapur, Navi Mumbai & Raigad = Shri S.K. Purkar, Law Officer; Nashik, Pune & Thane = Mrs. Netra Chaphekar, ALO//c L.O.; Mumbai, Kalyan & Nagpur = Mrs. Neelam Kubal, ALO and Kolhapur, Amravati & Aurangabad = Ms. Smita Gaikwad, ALO). They should get it filed through Subject – Specific – Advocates engaged in the matter atleast two days before the date of hearing / as directed by the NGT within stipulated period in the order. They should ensure that the panel advocates are briefed well in advance about the main para wise affidavit / additional / interim reports filed in compliance of the order. The following region wise advocates are engaged for preparing draft affidavits not involving policy decisions and important issues, which are to be finalized with the approval of local advocate only. They will be paid @ of Rs. 3000 /- for drafting and finalizing as well as affirmation of each affidavit not involving submission of application for filing of report or small affidavit filing of some document or joint vigilance sample reports or report of expert without any elaboration. The bills are to be certified by the concerned Regional Officer and to be submitted through Policy and Law Division directly to HQ(CAO), MPCB.

The following region wise Advocates approved for the purpose of preparing draft affidavits, affirmation thereof and thereafter, concern ROs to get it filed well in advance before NGT as stated above.



The affidavits in respect of important issues with policy decisions are to be prepared in the form of draft para wise reply and to be sent to the Policy and Law Division to decide further course of action atleast one week before the date of hearing. The concern ROs to ensure that such affidavits are finalized atleast five days before next date and with the approval of HQ to be filed atleast two days before next date of hearing. In appropriate cases, concern subject in charge / HOD as decided by the Policy and Law Division to attend NGT, to brief Panel Advocates, to get affirmed the affidavits out of their impress amount, to get copies thereof for service with the aid and assistance of their field officers. Where ever required they may contact the field officer at Pune, who has been exclusively deputed for NGT matters. In case of ambiguity, the P & L Division at HQ to be contacted and as per its advise, further actions are to be taken.

This is issued with the approval of Member Secretary to strengthen the attendance of NGT matters on top priority basis and in order to comply with various orders passed by the NGT in letter and spirit. The names of the other Advocates will be communicated as and when received.
