CIRCULAR

Sub: Four online applications – C2E, C2O, C2R & Hazardous Waste Authorization (Form-1) for new Registered units will be be available on 'MAITRI' portal.

Ref: 1. Circular no.AST/IMIS/webportal/429 dated 28/01/2016

2. DIPP's mandate under 'EASE OF DOING BUSINESS' Project

Maharashtra Pollution Control Board has been covered under the Maharashtra Right to Services Act, 2015, ensuring grant/refusal/disposal of applications for grant of consent and authorization under the provisions of the Water (P&CP) Act, 1974, the Air (P&CP) Act 1981 and the Hazardous Waste(MH&TB) Rule 2008 respectively and Maharashtra Government as an initiative of 'Ease of Doing Business' in the State of Maharashtra has adopted the procedure for online submission of various applications for various statutory permissions, so as to dispose of the application for such statutory permissions from various Government departments within stipulated statutory period. The Environment Department, Govt. of Maharashtra with the approval of State Government has issued GR in this regard which is hosted on the State of Maharashtra website.

Accordingly, Maharashtra Pollution Control Board has developed Web Portal for online submissions of applications for consents under Water and Air Act along with an application for Authorization under the HW Rule 2008 & amendment thereof. Accordingly, entrepreneurs are submiting their applications online through this Webportal — "ec-MPCB", which link is available on Board's website with URL: www.ecmpcb.in and also at Government's web-portals namely - 'Aaple Sarkar' & 'MAITRI' portal.

Now, as directed by DIPP under 'Ease of Doing Business' project it is decided that major four Online Services namely – 'Consent To Establish, Consent to Operate, Consent to Renewal and Hazardous Waste Authorization (Form – 1), for new Registered User, will be available on 'MAITRI' portal only. The entrepreneurs will now have to register with MAITRI portal (URL: https://maitri.mahaonline.gov.in)and then it will be redirected to MPCB's web-portal – 'ec-MPCB' for further submission of online applications (only four services). Rest other online applications will be available on MPCB's web-portal 'ec-MPCB'. Moreover, existing users, who have already registered with MPCB's Web-portal can directly apply through MPCB's 'ec-MPCB' web-portal. The 'MAITRI' online application for above referred four services is only for new online

applicants who have not yet Registered on MPCB's portal. The updated guidelines are available on ec-MPCB's web-portal and also on MPCB's website.

This above referred MAITRI and ec-MPCB integration for above online four services (Consent to Establish, Consent to Operate, Consent to Renewal and Hazardous waste Authorization (Form-1) will be implemented with immediate effect.
