Standing Order

Maharashtra Pollution Control Board in its 147th meeting of the Board held on 22.4.2008, resolved that the Board will recover lapse period consent fees and delayed payment charges from the industries, operations or processes, being established and operated without obtaining valid Consent/s and Authorization or obtained it after lapse of certain period, thereby creating a situation of discrimination against those who obtained it. A circular was issued by the Board for making applicable Lapsed Period Consent Fees and Delayed Payment Charges in respect of grant of Consents / Authorizations under various Environmental Laws by letter dtd. 17/07/2008 and accordingly, the Lapsed Period Consent Fees and Delayed Payment Charges in respect of grant of Consents / Authorisations have been made applicable w.e.f. 17/07/2008.

The Board further observed that, in spite of imposition of above nominal penal charges, there has been a tendency of establishing and operating industries, operations or processes without obtaining Consent to Establish and Consent to Operate, thereby, not complying with various environmental norms and standards, causing environmental pollution / violation in the surrounding area. The issue was discussed in the 15th Consent Committee Meeting held on 14.9.2010 and it was decided to put up appropriate Item Note before the ensuing Board Meeting.

Accordingly, an Item Note was put up before 151st meeting of the Board held on 1.10.2010. The item was discussed at length. After, due deliberation, the Board has resolved that "the imposition of penal charges @ 10 times of the Consent fees should be considered, so as to discourage the delayed applications for consent for such a longer period and to promote timely payment of consent fees with the application for consent. It was also decided that, the Board will start execution of said scheme by giving four months time to all such units and thereafter, imposing 10 times penal rates as such on un-consented units, followed by filing of prosecutions and issuance of appropriate directions including closure and disconnection of electricity/water supply etc. The Regional Officers are therefore, directed to issue unconsented industries, operations or processes

necessary warnings about making applications for Consent/s and Authorisations by giving period upto 18/02/2011, failing which, the Board will consider imposition of penal charges @ 10 times of consent fees, so as to discourage the delayed applications for consent and to promote timely payment of consent fees with the application for consent, followed by filling of prosecutions and issuance of appropriate directions including closure and disconnection of electricity / water supply etc.

The Board has decided to impose such penal rates w.e.f. 1st April, 2011, i.e. new Financial Year. All the Officers of the Board should implement these directions scrupulously and strictly.
