Sub: Revision of delegation of powers about Consent

Management in the Maharashtra Pollution Control Board,

Ref: Minutes of the 159th Board Meeting held on 18/2/2013.

The Board in its 159th Meeting held on 18/2/2013 has considered the revision of delegation of consent management powers granted to the various officers of the Board as well as the Consent Committee and the Consent Appraisal Committee including the Member Secretary and Chairman of the Board vide Office Order No.E-17/2008, dtd.18-2-2008 / 7-3-2008 respectively.

The Board has taken into consideration various improvement measures undertaken by the Consent Appraisal Committee and Consent Committee in respect of disposal of Consent & Authorization applications received by it under various Environmental Laws for expeditious disposal thereof. The Board has also noted that an Uniform Integrated Approach has been adopted by both the Committees by evolving necessary procedure to dispose off such applications in a time bound manner. The concept of Auto Renewal has also been introduced to encourage the applications for auto renewal on the basis of self-certification in respect of compliance of various conditions imposed in the earlier consent.

After adopting all these procedures for quick disposal of the consent applications, it is proposed that in order to bring more simplicity in the consent management and to adopt more consultative process in the consent management for the applications in respect of the industries, operations or processes having more investments and pollution potential, instead of the processing of applications at Member Secretary and Chairman level, the applications above certain capital investment and having certain pollution potential, shall be discussed at the Consent Committee and Consent Appraisal Committee level. In order to concentrate more on the overall supervision & control of the activities of the Board, it was resolved that the powers granted to the Member Secretary & Chairman of the Board will be decentralized amongst the officers of the Board and both the committees of the Board constituted for the purpose of recommending grant, suspend or refusal or revocation of consent. Accordingly, the Board approved the proposal in respect of revision of delegation of consent management powers as per the Annexure-'i' enclosed to the Minutes of the Board Meeting held on 18/2/2013, in respect of Table Item No.3.

The revised delegation of consent management powers are being issued in two stages i.e. firstly, the powers delegated to the Regional Officers and above, which have been connected to the network and secondly, the powers delegated to the Sub-Regional Officer will be issued after connecting their offices to the network of

consent management. The powers in respect of the 1st stage are being hereby
