National Green Tribunal

NGT has been constituted under the provisions of the National Green Tribunal Act, 2010. It's one of five benches, is being established and being operated bench for western region at Pune, the cultural Capital of Maharashtra. The following are the important features of the Tribunal:

- The Jurisdiction of the Tribunal in respect of Environmental issues have been limited to all civil cases, more particularly, where a substantial question relating to Environment arises or which also includes enforcement of any legal right relating to Environment and such question arises out of the implementation of enactments specified in the Schedule – I of NGT Act, 2010.
- The Schedule I specified the following Acts for the implementation
 - a) The Water (P&CP) Act, 1974.
 - b) The Water (P&CP) Cess Act, 1977,
 - c) The Forest (Conservation) Act, 1980,
 - d) The Air (P&CP) Act, 1981
 - e) The Environment (Protection) Act, 1986
 - f) The Public Liability Insurance Act, 1991
 - g) The Biological Diversity Act, 2012.

Since the NGT has been given wide powers to entertain an application/s for relief and compensation to the victims of pollution and other Environmental Damage arising under above specified Acts under Schedule – I, including accidents occurred while handling hazardous substance or restitution of damaged property/ Environment as well as Appellate Jurisdiction in the matter of the orders passed by the various authorities under various specified Acts under Schedule – I including Appellate Authorities constituted under those Acts, now the responsibility of Regulatory Authorities under the above Acts have been considerably increased in the sense that those Authorities will have to follow precedents laid down in the Judgments and Orders passed by the NGT.

- Since the NGT is constituted with Judicial and Technical/Scientific Expertise, having exclusive jurisdiction in the matter of Environment Protection, as observed after establishment of NGT, more issues will be brought before Honorable NGT and therefore the compliance level of Environment norms will be definitely increased on account of faster development of Environmental Jurisprudence.
- Therefore, the establishment and operation of NGT from Pune will be definitely a Landmark Step in the State of Maharashtra for better protection and improvement of the Environment of Maharashtra. The Regulatory Authorities will have to be more cautious and vigilant in implementation of various Environmental Laws.
