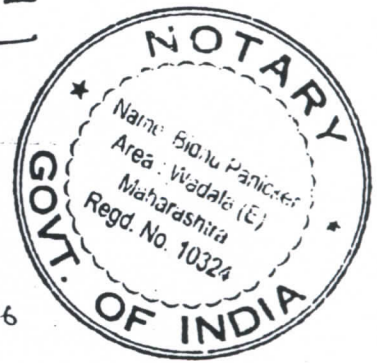

To permit use of Maidan at Shivaji Park, Dadar, Mumbai for non-sport functions.

PREAMBLE: PIL Petition No.116/2009 has been filed by WECOM TRUST, & OTHERS at Hon'ble High Court, Bombay. Government of Maharashtra and M.C.C.M. have been made Respondents in the said Petition. The Petitioners have raised issues like whether Shivaji Park Maidan is a Recreation ground and/or Play ground, Shivaji Park area be declared as Silence Zone and said Maidan is being used for the purposes other than the assigned purposes. The Hon'ble Hight Court Bombay has passed an Order dated 4th January, 2013 in this case.

As per the provisions of Section 37 (A) of M.R.T.P. Act 1966, the maidan at Shivaji Park, Mumbai can be used apart from sports for National Functions such as Independent Day, Republic Day, Maharashtra Day, Jayantis and Punnyatithis Functions of National Leaders, Public Meeting and religious purposes/festivals for 45 days in a year.

An advertisement was published in Daily News Paper dated 21.11.2016 seeking submission of Memorandum within 20 days of publication from those who wish to organise functions on balance 11 days after noting that as per the said provision and the order dated 4th January 2013 passed by Hon.'ble High Court, the Government had finalised to permit apart from sports, Baldin function, Republic day, Maharashtra Day, Independent Day, Ganeshji Emersion, Dasara Melawa and Dr. Baba Saheb Ambedkar Mahaparinirman Din function for total 34 days. After considering the memoranda received with reference to the said advertisement, the proposal was under consideration of the Government to permit every year use of maidan at Shivaji Park, Dadar, for functions other than sports. Government has taken the decision as follows:

Accordingly by this, Government is approving permission for use of maidan at Shivaji Park, Dadar, Mumbai for the following non-sport functions every year :

02. Subject to the following conditions being complied with, the MC, BMC may permit the use of Maidans at S.P, Dadar, Mumbai for the above events:

- a. Compliance with the provisions of the Noise Pollution (regulation & Control) Rules, 2000
- b. Compliance with the provisions of Order dated 4th Jan. 2013 of Hon.ble High Court
- c. Obtaining permission of Police Authority wherever necessary
- d. Compliance with such other terms & conditions as may be imposed by Mahanagar Palika while reserving the maidan.
