## C I R C U L A R

**Sub:** Documents/Information required for grant of consent for storage and handling activities in tank form applications-regarding.

- 1) Board office order NO. BO/RO- P&P/Office-Order/TB-2864 dated 02/05/2008.
  - 2) Minutes of Tank Form committee meeting dated 07/02/2009.
  - 3) The Manufacture, Storage and Import of Hazardous Chemicals Rules, 1989 and its amendments made thereafter.

In order to streamline the consent processing of tank form applications, RO/SRO shall submit the tank form applications with following information /documents as -

**i) Information:-**

Complete information regarding date of commissioning of the unit, distance & class of the nearest river /distance from coastal zone, capital investment of unit, number of tanks with storage capacity and name of chemicals to be stored, requirement of necessary clearances/ licensees from statutory organizations, identification of Major Accident Hazard (MAH) units for isolated storages/ Pipelines used for conveyance of Hazardous Chemicals in their regions etc shall be furnished in the consent applications.

ii) Documents:-

- a) Department of Explosive, Industrial Safety and Chartered Engineer approved Maps of the sites before & after 14/09/2006 prepared by the industry for storage and handling of hazardous chemicals.
- b) Copies of necessary clearances i.e environmental, location, RRZ, CRZ etc obtained from statutory organizations.
- c) Copies of necessary licenses obtained from statutory organizations.
- d) Copies of previous consent granted by the Board, if any.
- e) In accordance with the provisions of Manufacture, Storage and Import of Hazardous Chemicals Rules, 1989 and its amendments made thereafter, Occupier shall submit copies of MSDS of chemicals to be stored, safety & Safety audit reports, on-site emergency plans, Disaster Management plans prepared to prevent major accidents.

RO/SRO shall ensure that this circular is brought to the notice of all the operators of tank farms.
