Discussion: -

All the members of the committee have been informed about Hon'ble NGT directions dated 20/09/2018 w.r.t original application no.673/2018 regarding polluted River stretches in the country and submission of Action plan for rejuvenation of the polluted stretches and the formation of the Controlling committee for implementation of action plan & formation of separate Special Environment Surveillance Task force for the polluted river stretches district wise. The Environment Department, Govt of Maharashtra, vide letter dated 13/12/2018 has been directed to constitute a Committee of Five members under the chairmanship of the Principal Secretary (Environment) for implementation of the Action plan for the polluted River stretches in Maharashtra and Special Environment Surveillance Task force for District of polluted River stretches. As per office Order dated 29/06/2019 a District Special Environment Surveillance Task force committee has been formed. And First meeting of the nominated members has been conducted. letter was served on 09/07/2019 and invited to Chief officers of Municipal councils, Kamptee, Kanhan, Mouda, & Mahadula. Chief Officer of Municipal Council, Kanhan was absent and it has been decided to ask him to submit their Action plan for Solid Waste Management & treatment of Domestic sewage before discharging into Kanhan River. Representative of Nagpur Municipal corporation & Zilha Parishad were absent and it is decided to communicate them to subit their action plan in next meeting.

At the outset, information of the polluted river stretches in Nagpur District was discussed and probable pollution sources, illegal mining was discussed. Copies of action plan of polluted river stretches was served to every member.

Chief officer, Municipal council, Mouda, has submitted that, sewage Treatment Plant will be completed & commissioned by April 2021. He further submitted that, a site has been identified for MSW processing. Solid waste being segregated at source and organic waste is used for composting and Municipal Council is generating revenue from selling of composting.

Chief officer, Municipal council, Mahadula, has submitted that, sewage generated from the MC jurisdiction is discharging into Cooling pond of the Thermal Power Plant, Koradi, and it is proposed to provide Sewage Treatment Plant by MAHAJENCO.

Chief officer, Municipal council, Kamptee, has submitted that, the work of underground sewage carrying pipeline is 80 % completed and it is proposed to provide Sewage Treatment plant of capacity 12 MLD at Survey no.29. The proposal of STP will be resubmitted to the Maharashtra Jeevan Pradhikaran for Technical approval.

During meeting it is suggested to invite District Mining Officer in second meeting for review of illegal mining.
