The data has been extracted from the MPCB Portal for the category of Chemical sector, as per the revised classification of the industry dtd. 07.03.2016, which are enlisted as below...

- > R-22 Organic Chemicals manufacturing,
- ➤ R-25 Basic Chemicals and
- ➤ R-58 Pharmaceuticals
