Dr. V. M. Motghare, JD(APC) could not attend the meeting, leave of absence was granted to them.

Assistant Secretary (Tech.), MPCB, Member convener of the Committee, welcomed the Committee members, and give the outline idea and necessity for formation of Committee by the Board.

Due to illegal disposal of Hazardous Waste so call by product/chemicals/HW in recent past, Board has decided to consider by-products only after fallowing the due procedure for defining the By product. The by-products which are not confirm the definition of By product and does not have commercial value, and not useful as Raw material to manufacture a new product without its pre-treatment, needs to be define as HW and will be shifted to the Hazardous Waste Section and consent amendment accordingly. Various industries have submitted their representation in respect of the same and requested the Board to allow them to sell as a by-products as they don't find buyer who has register under Rule-9 of Hazardous and Other Waste Rule, 2016 to process their waste/use as raw material for manufacturing their product.



By considering above and to have more clarity about By product and HW, the Board had constituted a committee on 12.03.2019. As per TOR, the committee shall examine the details of the consent to operate granted by the Board at various levels (i.e. Regional Officer, Head of the Department, Consent Committee, and Consent appraisal committee) and The committee shall examine the technical presentation made by industry or Environmental Auditor. Based on the presentation and examining the case, the committee will decide about the by-products and hazardous waste and shall ask for the consent amendment accordingly.

Thereafter, The CPCB had issued the guidelines in May 2019 for Identification of Materials Generated from Industrial Processes as Wastes or By-products [Hazardous and Other Wastes (Management and Transboundry Movement) Rules, 2016].

- By-products which are claimed can be used by other authorized users without any treatment. For this needs to obtain undertaking that such byproduct (Chemical) is used by them as authenticate raw material for users' intended product.
- ii. By-products users should have declared the % purity requirements by them and has to mentioned the particular name as raw material in their CTE/CTO application. Means the user should be an authorized one.
- iii. By-product generator should have traceability mechanism and should take form their users a monthly statement of consumption.
- iv. By-products shall be dispatched directly to the consumer, by generator of by-products, through the transporter having GPS and not through dealers.
- v. Generator of by-product should submit monthly statement of their sale and statement of consumption by the respective user.
- vi. After use of by-product consumer shall treat the effluents as per MPCB norms. Such impure by-products can generate effluents than virgin raw materials. This is applicable for spent acids, mix solvents, impure by-product but can be used in process of other products such as paints, varnishes, thinners, boot polish etc. Certain by-products can be good quality chemicals or can be purified to acceptable levels required by users.
- vii. Chemicals which are not fitting in above points shall not be considered as by-products and shall be treated as Hazardous Waste.

By-products already mentioned in the existing consent Asst. Secretary (Tech.) informed that, as per the Board's record, more than 400 industries are having their consents mentioning products and by-product which needs further examination/evaluation and based on findings consent amendments accordingly.

The committee noted that, as per the guidelines issued by the CPCB the industries which are having the EC and by-products are mentioned in the EC, need not to be evaluated further for by-product or Hazardous waste. However, during the earlier CAC meetings, the issue of by-products and HW was discussed and the decision was taken that, though the guidelines given by the CPCB, not to further evaluate /verify the by-products mentioned in the EC, there is need of verify on the basis of end use, chemical compositions, purity, further reprocessing, economic viability, etc.

After due deliberation, it was decided that,

- It was decided to prepare the separate list of the industries which have obtained EC wherein the by-products are mentioned. This work shall be completed, by forming the subcommittee consisting of a SRO and two FOs of AS(T) section, within three months.
- The industries not having EC or having EC but without mentioning by-products and having the consent mentioning by-products, the PP shall be inform immediately by sending letter/mail for submitting the application in prescribed format for evaluation of by-products and HW, with in a period of one month.
- The industries those have obtained EC mentioning by-products also needs to be evaluated, as per the guidelines. Further, considering CAC decision needs to evaluate/verify such cases by obtaining following information from the industries.
 - i. End use of chemical,
 - ii. Chemical compositions,
 - iii. Purity of material,
 - iv. Further reprocessing,
 - v. Economic viability, etc.
- ➤ The existing consents mentioned byproduct, shall be placed before committee for verification. It was decided to place around 50 cases/meeting and committee will meet twice in a month.
