The pre-bid meeting was organized to address the queries raised by the bidders for the said tender. This tender is a re-tender for Supply, Installation, Commissioning and Operation and Maintenance of Continuous Ambient Air Quality Monitoring Stations (CAAQMS) – 47 nos. in Maharashtra, the pre- bid reply of earlier etender No:975 remains the same and applicable for this tender [e-proc tender ID: 2020_MPCB_603779_1] also.
