Dr. V. M. Motghare, Joint Director (APC) has welcome Hon'ble Chairman and monitoring committee members and MPCB Officials present for the meeting and gave brief background & presentation in the matter-OA No. 11 of 2013 Raghunath Lokhare Vs MPCB and Others.

Dr. V. M. Motghare, Joint Director (APC) has submitted that earlier there are two committees formed by MPCB i.e Core Committee and Technical Committee to resolve the said issues and further presented short term action plan prepared by the MPC Board.

The Hon'ble District Collector has made suggestions that for ground water recharge, rainwater harvesting at different villages awareness programmes shall be conducted by the local authority. The expenditure for said awareness programmes will be done through Escrow Account maintain by District Collector, Aurangabad.

After due deliberation it was decided to follow the line of action as under -

- Short terms action plan prepared by the MPC Board shall be implemented immediately.
- Soil contamination was also observed in the area, hence phytoremediation or better technology may be adopted in the affected area to bring down contaminated soil to it's original entity.
- 3. GSDA shall carried out remapping of aquifers in the contaminated area.
- Local officials of GSDA shall assist the monitoring team appointed for remapping of aquafers.

 Piezometric wells shall be provided by the MIDC at different locations in MIDC alongwith periphery of MIDC area & water level & water quality shall be check fortnightly.

Reputed institute like IIT, NEERI, Govt. Engg. College A'bad etc... alongwith GSDA shall be appointed for assessment / study of various methods for remediation of

contaminated ground water.7. All expenditures shall be done through escrow account available with District Collector, Aurangabad

The Hon'ble Chairman, MPCB has further suggested to prepare action plan for remediation assessment /study of various methods by engaging reputed institute like IIT, NEERI and TOR shall be finalized by the MPC Board. Also, Hon'ble Chairman suggested that Monitoring committee shall visit the site.

Dr. V. M. Motghare, Joint Director (APC) has expressed vote of thank to the Chair.
